Starter Kit for joining The Texas Assembly – Quick Option using a Public Notary

Do this before proceeding:



- 1. Go to Walgreens and purchase 2 to 4 passport photos. Wear a dark shirt. The extra Passport photos will come in handy later
- 2. Get a whole package of good blue pens and get 1 or 2 red pens
- 3. Get a red ink pad so you can put your right thumbprint on the area of the last 2 letters of your last name when autographing your papers. You will do this in normal life a lot from now on.
- 4. Glue to affix your passport photos to the 2 witness statements

Now you are ready to find a Public Notary to have your papers filled out/notarized. If your witnesses are not in the area, that is ok. You will have to mail them your passport photo to attach to the witness statement you email them. Then they will have to mail you back the inked/original copy. Hopefully they are local to make things easier.

Fill-out and Autograph ALL papers in this downloaded packet. Some are duplicated as they will be needed later, like 3 Declarations of Political Status and 2 witness statements (1 for each witness).

Once you have all the original inked papers notarized, you will need to send an email to: paperwork@thetexasassembly.land – Put in the Subject Line "My Papers are done, Where do I mail them" Then the Recorder on rotation that checks this email account will have you mail them to their home office. FYI: You must include a self-addressed/stamped envelope with your package so the Recorder can snail mail you back the originals once he/she records & uploads them to our online public Land Recording Office.

NOTE: Recording and publishing fee is \$75 per session (unlimited docs you have ready at once) per man/woman;
